

## Guide to Health Insurance for Foreigners

**Health Insurance for Foreigners** is insurance required for legal stay on the territory of the Czech Republic (work, tourist or study) and used for the payment of your health care in the Czech Republic (ext. the area of Schengen). Here you can find basic information and the below questionnaire, on the basis of which the employee of Slavia Insurance company will prepare an insurance contract.

### HOW DOES THE ARRANGEMENT OF INSURANCE CONTRACT WORK AND WHAT ALL WILL I RECEIVE?

- After filling up and delivery the questionnaire below your insurance contract will be made, that you sign. Part of the insurance contract is the Record of the meeting, where your requirements are noticed, and General terms and conditions of the insurance policies, where you are given details according to the extent of insurance coverage.
- After the signing and payment of the insurance contract (it is possible to pay in cash or by credit card), together with the insurance contract you will obtain also insurance card. Keep our insurance card together with receipt proving your payment in case of control by Police of CR or when you are visiting a doctor.
- At the same time you will be provided by a list of contracted healthcare organisations/hospitals. In the case you need healthcare, we recommend that you visit one of these listed healthcare organisations/hospitals, you will not have to pay for the healthcare. Of course, you can visit any healthcare facility, but most probably you will have to pay for the care in cash and then send the documents/ bill to the Insurance company to be refunded.

Anytime you can contact our telephone Assistance line (provided by Eurocross company), that will help you in the necessary moment and will guide you. The telephone number is written on the Insurance card. The Assistance line provides services in several languages (English, German, French, Russian etc.).
